DAY HOSPITAL

Day hospitals must be stand-alone facilities (or, if partially owned by an in-patient hospital, then independently managed). If part of a Group, each individual licensed day hospital must pay a Membership Fee and cannot come under one Membership.

Cost \$980 + \$115 Joining Fee

PRELIMINARY

Membership is as per Day Hospital Member (below) but may be in the pre-build or build-phase and therefore, have not yet achieved State Health Department Licensing or Accreditation however, this will be reviewed annually by Day Hospitals Australia.

Cost \$980 + \$115 Joining Fee

AFFILIATE

Small overnight private hospitals <100 licensed beds unaffiliated with any other overnight private hospital.

Cost \$800 + \$115 Joining Fee

INDIVIDUAL / PROFESSIONAL

A member who is a natural person and can demonstrate extensive experience, knowledge, active involvement and commitment to the day hospital sector during their professional career in the Private Health Sector.

Cost \$400 + \$115 Joining Fee

INDUSTRY

Industry membership will be accepted from persons or companies working within the health environment. All applications are subject to Day Hospitals Australia CEO approval.

Cost \$1500 + \$115 Joining Fee
