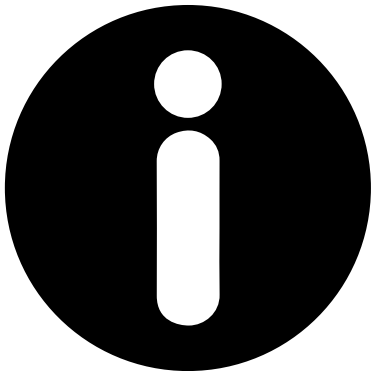
PEAK BODY DAY HOSPITAL SECTOR
