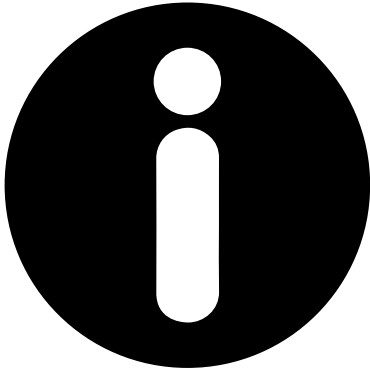
## PEAK BODY DAY HOSPITAL SECTOR
