## MEMBERSHIP LEVELS & ANNUAL FEES

#### DAY HOSPITAL MEMBER

Day hospitals must be stand-alone facilities (or, if partially owned by an in- patient hospital, then independently managed). If part of a Group, each individual licensed day hospital must pay a Membership Fee and cannot come under one Membership. Cost \$1,060 + \$119 Joining Fee

#### PRELIMINARY MEMBER

Membership is as per Day Hospital Member (above) but may be in the pre-build or build-phase and therefore, have not yet achieved State Health Department Licensing or Accreditation.

Cost \$1,060 + \$119 Joining Fee

#### **AFFILIATE MEMBER**

Small overnight private hospitals <100 licensed beds unaffiliated with any other overnight private hospital.

Cost \$1,000 + \$119 Joining Fee

#### INDIVIDUAL / PROFESSIONAL MEMBER

A member who is a natural person and can demonstrate extensive experience, knowledge, active involvement and commitment to the day hospital sector during their professional career in the Private Health Sector.

Cost \$438 + \$119 Joining Fee

#### **INDUSTRY MEMBER**

Industry membership will be accepted from persons or companies working within the health environment. All applications are subject to Day Hospitals Australia CEO approval.

Cost \$1,606 + \$119 Joining Fee

A Group Discount may apply for facilities where more than one facility is owned by the same owner (Day Hospital, Preliminary and Affiliate members only).

Evidence of State/Territory Department of Health Licensing and Accreditation status must be provided upon joining (Day Hospital and Affiliate members only).
