Day Hospitals must be stand-alone facilities (or, if partially owned by an in-patient hospital, then independently managed). If part of a Group, each individual licensed day hospital must pay a Membership Fee and cannot come under one Membership

Membership Fee: \$1092 + \$123 joining fee (ex gst)

## Preliminary Member

Membership as per Day Hospital Member (above) but may be in the pre-build or build-phase and therefore, have not yet achieved State Health Department Licensing or Accreditation

Membership Fee: \$1092+ \$123 joining fee (ex gst)

## Affiliate Member

Small overnight private hospitals <100 licensed beds unaffiliated with any other overnight private hospital.

Membership Fee: \$1030 + \$123 joining fee (ex gst)

## Individual / Professional Member

A member who is a natural person and can demonstrate extensive experience, knowledge, active involvement and commitment to the day hospital sector during their professional career in the Private Health Sector.

Membership Fee: \$451 + \$123 joining fee (ex gst)

**A group discount may apply for facilities where more than one facility is owned by the same owner (Day Hospital, Preliminary and Affiliate members only)**

**Evidence of State/Territory Department of Health Licensing and Accreditation status must be provided upon joining (Day Hospital and Affiliate members only).**
